Subject: - To permit schools vide Code 18th of Free and Compulsory Education of Children Act 2009 and Rule 11 Sub Rule (4) vide Free and Compulsory Education of Children Act 2009

Sir / Madam,

As per your application dated **23/09/2019**, and on the basis of subsequent correspondence with the school / site visit of the school / examination of the school carried out by me, I Education Officer (Primary), District Council Thane, hereby permit EVA World School at Hedutne, Dombivli East, Tal: Kalyan, Dist.: Thane (with the name and the address of the school), from the period of three years from **01/04/2019 to 31/03/2022** for **Standard 1st to 8th**. This permission is subjected to the observance of below mentioned conditions:

1. Sanction period shall not be extended and there shall be no restriction in any situation for the sanction or affiliation after 8th Std.
2. Every school must fulfill the provisions mentioned in the Free and Compulsory Education of Children Act 2009 (annexure 1) and Maharashtra Free and Compulsory Education of Children Act 2011 (annexure 2).
3. The school shall admit in the 1st Standard at least 25% of the children of the weaker and deprived sections from nearby areas and until they complete their primary education, they shall receive free and compulsory education. But it is also that the same ratio shall be applicable for pre-primary section too.
4. As mentioned for the children mentioned in the Para three, the school shall get a separate bank account so as to receive reimbursement, as per the code 12 (2) of the Act.
5. The school shall not accept any capitation fee, neither at the time of admission nor thereafter or no compulsion of any verification shall be entitled to the students and parents.
6. No child is restricted from admission on the school, in case of any unavailability of any proof of religion, caste and creed, place of birth or for any reason thus mentioned.
7. (i) Any child admitted in the school shall neither be held in the same standard in which he studies nor he shall be expelled from the school until he / she completes primary education.
(ii) No child shall undergo any physical punishment or mental harassment.
(iii) No child has a compulsion until he / she completes primary education to pass any exam held by any board.
(iv) The child that completes primary education shall be given a certificate as per the rule 23.
(v) Teachers with minimum eligibility criteria as per the code 23 (1) of the Act shall be appointed. But it also that those teachers; who do not have minimum eligibility criteria on the date of commencement of the act shall need to acquire it within 5 years period.
(vi) As per the code 24 (1) of the Act, teachers shall fulfill given responsibilities.
(vii) As per the code 24 (1) of the Act, teachers shall fulfill given responsibilities.
(viii) The school shall ensure that no teacher shall be engaged in personal tuitions.
